Nikki Quinn Spoke for the motion

The debate was opened

- Dorothy Chanakira (President Golden Gavel) spoke for the motion. In 2015 a
 member won the District Evaluation Contest. In 2021 that same member, Verity
 Price won the World Championship of Public Speaking. It is our responsibility to
 give our members the opportunity to evolve.
- Lorraine Pendula (Division Y Director) *spoke against the motion*. Our priority is to rebuild clubs and grow membership that has dropped during the pandemic. Evaluation and Table Topic contests will distract us. We should postpone this decision for another year, to allow us to focus on membership growth.
- Wence Kutekwatekwa (Area Director, Z5) spoke for the motion. The reason we
 have a membership problem is because the 'Fun' is missing in meetings. Table
 Topic and Evaluation contests will help to bring the fun back into Toastmasters.
 Other districts are holding these contests.
- Andrew Tsuro (Program Quality Director) spoke against the motion. Contests are
 fun, but the orgainsation is protocol centric. The priority is rebuilding quality
 clubs, let us allow the clubs who are able the option to hold contests at club level
 and allow other clubs the time to focus on education and growth, without the
 distraction of contests.
- Zeenat Fugurally (Area Director, B3) spoke for the motion. Competition allows
 members to measure growth. Division B wants to train members in contests as
 they were previously un-districted and unable to participate beyond country level.
 Now they will be able to measure growth against others in the district. Contests
 will contribute to member and membership growth. Last year Mauritius was able
 to hold all contests, District 74 can surely do the same?
- Keamo Molebalwa (VP Education, Midrand Ground breakers) *Spoke against the motion*. As VPE putting a program together for each meeting is a strain, contests will add too much additional pressure.
- Johnathene Beyers (President, Morningside) *spoke for the motion*. Contests allow small steps in member growth.
- Bhekisisa Ngomane (Division Director, A) Spoke against the motion. District
 mission is to build new clubs and support all clubs. The logistics required to
 deliver contests takes away from the mission. Park additional contests as we do
 not have the resources to do this.
- Maria Teresa Huber (VPE Executive Club, Division Z) *Spoke for the motion.* the achievement of Verity Price is the reason to hold contests.
- Noma Muzunze (AD, Z4) Spoke against the motion. Our plates are full with rebuilding our lives and our clubs after the pandemic. Let us not lose focus of the District Mission, we do not have the capacity to run additional contests.
- Nikki Quinn summed up and thanked everyone for the robust debate. Variety is
 necessary in our growth but is missing at area and division level as we do not
 compete against others in theses contests. A part of the district experience is not
 there now.
